Freedom Christian School is a distinctive Christian educational institution. FCS is for dedicated students who are sensitive to the principles of Christian life and conduct as set forth by God's Word.

A student's registration is regarded as a pledge on his/her part to abide by the school's specific guidelines detailed in the Student Handbook. FCS recognizes that while such man-made regulations cannot improve an individual's life with Christ, they do strengthen the life and testimony of both the student and school he/she represents. To this end, FCS expects students to refrain from the participation in activities where alcoholic beverages, illegal drugs, and tobacco are present and from activities involving sexual immorality. Further, the school is quite concerned about the morally degrading elements that are now found in most forms of entertainment media, music and literature. Discretion is necessary in the participation in these forms of entertainment. Also, a dress code has been established for male and female students to aid in proper conduct and appearance as a visual testimony.

If, in the judgement of the school's administration, a student's action or attitude is contrary to these guidelines and standards, they will be warned and disciplined if necessary (which could include dismissal if the wrong actions or attitudes continue or seem flagrant).
